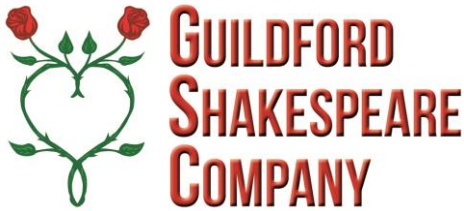

GSC Classes Terms & Conditions

1. All fees are due on or before the start of each term. Accepted forms of payment are BACS transfer, Cheque or Cash. Cheques must be made payable to "Guildford Shakespeare Company."
2. An option to pay for the course in instalments is available. This option MUST be agreed in writing by Guildford Shakespeare Company before the start of term.
3. Fees are non-refundable.
4. Fees are reviewed annually in September.
5. Classes start promptly at the published times and Guildford Shakespeare Company must be informed of any late arrival or absence as soon as possible.
6. Guildford Shakespeare Company must be informed of any dates that students will be unable to attend e.g. school trips, holidays etc. at least one week in advance. Inability to make the advertised dates may result in a child's exclusion from the final performance.
7. Food and drink may only be consumed at break times.
8. Guildford Shakespeare Company will not tolerate rudeness, bullying, or any inappropriate behaviour and reserves the right to exclude students from lessons at its discretion.
9. Mobile phones must be switched off for the duration of the class.
10. Photographic images of students may be taken in rehearsal and performance for use on the Guildford Shakespeare Company website and any advertising/promotional literature.
11. Guildford Shakespeare Company reserves the right to make changes to the timetable and to the teaching staff.
